

TERMS OF USE / RESTRICTIONS

YOU SHOULD KNOW THIS

Welcome to All Inclusive and Half Board Fees Calculator (**the “Calculator”**) of **RCI, LLC**. (formerly **Resort Condominiums International, LLC**), branches, affiliates and/or subsidiaries (hereinafter referred to jointly as **“RCI”**). The purpose of this Calculator is to facilitate data flow between the Resort, RCI and RCI Member regarding All Inclusive and Half Board Fees, projecting calculation of fees and promotions applicable to Resort of interest, on selected dates. Please carefully read our terms of use, restrictions and notices contained herein (**the “Terms”**) before continuing using this Calculator. These Terms shall govern the use of the Calculator and are applicable to all visitor traffic of such tool. By accessing or using the Calculator, you agree with expressly accept these Terms. The Terms are with the purpose to protect all our visitors and use of the Calculator shall mean your acceptance of the Terms. IF YOU DO NOT AGREE WITH THESE TERMS, PLEASE ABSTAIN FROM USING THE CALCULATOR.

For the purposes of these Terms, initialized terms and/or definitions used herein shall have the meaning assigned thereto in the Terms and Conditions under the RCI Membership, unless the text of this instrument expressly assigns other meaning thereto.

In accordance with our purposes, the Calculator will allow you obtaining quotations in the RCI Affiliated Resorts, according to your preference. Such quotations generated by the Calculator are subject to stock availability at each Resort searched and do not include the Exchange Fees established by RCI. To check availability of Units and the corresponding Exchange Fee, the Member shall visit website rci.com or contact his RCI Vacation Guide.

Fees and promotions appearing in the Calculator, as well as its terms and conditions are determined and provided only by Resorts and are exclusively for RCI Members and Non-member programs authorized by Resorts, for such reason, they are to be subject to changes without prior notice by Resorts. The Calculator will display quotations in the currency provided by each Resort. For any clarification on the terms and conditions applicable to each promotion, including prepayments, you should contact your RCI Vacation Guide.

AMENDMENTS TO THE TERMS

The Terms may be changes without prior notice; thus, you will be the responsible to review the Terms every time you use the Calculator. **RCI** may amend, change or otherwise update these Terms at any time. Such amendments may be effective immediately upon publication thereof. By using the Calculator, you agree to be subject to the Terms, which shall be deemed read and understood by you as to the contents and legal scope as of the first time you use it.

PRIVACY

Privacy policy (**the “Privacy Policy”**) describes the type of data we require from you, how we use it and how can you correct or change such data. For additional information, please check in full our Privacy Policy.

The Calculator is controlled and operated by **RCI**.
